Attracted USD 6.19 billion FDI equity inflow during April 2014 to March 2023

## Supportive Policy Environment

### Business & Regulatory Reforms:

- 100% FDI permitted in Food Processing, Retails trading including e-commerce
- 40,000+ compliances reduced
- The National Single Window portal hosts applications for approvals from 31 Central Departments and 22 State Governments
- Agro-Processing included in priority sector lending – loans upto INR 100 crore per borrower

### Tax Reforms:

- One of the lowest corporate tax globally at 15% for new businesses
- Remission of duties and taxes incurred on exports from India
- 100% exemption of Income Tax on profits and gains for new Food Processing Units for the initial five assessment years

### Other Reforms :

- FSSAI - Shift from product-by-product approval to an ingredient and additive-based approval process
- Credit Guarantee Fund Trust for Micro and small Enterprises (CGTMSE)

# World Food India 2023

In recognition of 2023 being designated as the International Year of Millets and to foster collaboration within the global food processing industry, the Ministry of Food Processing Industries, Government of India organised the 2nd edition of "World Food India" from November 3rd to 5th, 2023 at Bharat Mandapam, New Delhi. The event was one of the biggest congregations of global investors and business leaders of major global and domestic agri-food companies, government departments, and dignitaries.

The event was inaugurated by the Hon'ble Prime Minister of India **Shri Narendra Modi** on 3<sup>rd</sup> November 2023 at the Plenary Hall of Bharat Mandapam. The valedictory session on 5th November 2023 was graced by Hon'ble President of India, **Smt. Droupadi Murmu**.

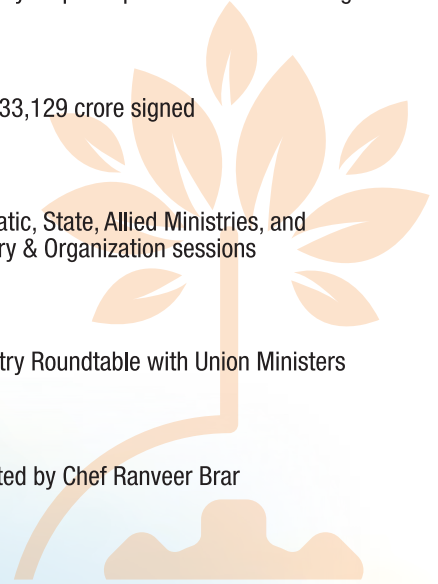
