- **3.0 E-Procurement under Two Bid System through GePNIC-Central Public Procurement Portal** shall be followed for this tender. Bidders should take due care to submit tenders in GePNIC-CPPP (https://etenders.gov.in) in accordance with the requirements. Bid Evaluation Criteria at Annexure-IV of the Bidding Document shall be the basis for evaluation of tender.
- **3.1** Please note that all tender forms and supporting documents are to be submitted through GePNIC-CPPP (https://etenders.gov.in) only.
- **4.0** Offer sent without having the prescribed Bidding Document of ONGC and without complying with the terms and conditions of Bidding Document for submitting the offer, will be ignored straightaway.

5.0 **PRE-BID CONFERENCE:**

- 5.1 In order to avoid clarification/confirmation after opening of bids, Pre-bid conference shall be held on **31.07.2024** at **11:00 Hrs. (IST)** so as to provide an opportunity to the participating bidders to interact with ONGC with regard to various tender provisions/tender specifications, before the bids are submitted.
- **5.2** Bidders are advised to download the tender documents well in advance prior to the pre-bid conference date, providing sufficient time for response.
- **5.3** The pre-bid queries shall be restricted to Technical specifications, scope of work, Technical BEC, special conditions of contract and mobilization/ delivery/ completion period only and that no queries whatsoever shall be entertained on provisions of GCC and other standard provisions/ proforma/ format of the tender document. The pre-bid queries shall be submitted in writing through GePNIC-CPPP (https://etenders.gov.in) on or before **26.07.2024**, for the purpose of discussion in pre-bid conference.
- 5.4 After pre-bid conference, the specifications & other tender conditions will be frozen. No change in specifications and tender conditions will be permissible after bid opening. All the bidders must ensure that their bid is complete in all respects and conforms to tender terms and conditions, BEC and the tender specifications in to failing which their bids are liable to be rejected without seeking any clarifications on any exception/deviation taken by the bidder in their bid.
- **5.5** The bidders meeting following requirement shall only be considered for attending the pre-bid conference.

- **9.0 PARTICIPATION OF CONSORTIUM IN THE TENDER:** Bids from consortium of companies shall not be considered.
- **10.0** Tender is invited under ROFR guidelines issued vide DGS Circular No. 02 of 2021 under PPP-MII -2017 (As amended from time to time).
- **11.0** Firm(s) to whom no further business is to be given or dealings with whom have been banned / suspended are not eligible to participate in the tender and any bid received from such firm(s) shall not be considered.
- **12.0** Bidders should indicate the complete details of vessels offered in the bid format at Appendix-17 A under Annexure-I A of tender document.
- **13.0** All the bidders have access to online help document which is available on GePNIC-CPPP (https://etenders.gov.in). This help document should be used by them for participating in this e-procurement tender.
- **14.0** Addendums/amendments to tender conditions, if any, will be uploaded on GePNIC-CPPP (https://etenders.gov.in).

15.0 FREQUENTLY COMMITTED ERRORS:

Bidders should ensure compliance of following while preparing the bid to avoid clarification/rejection of bid:

- 1. The annual financial reports as per BEC clause B.2.6.0 should be audited and complete with all notes and schedules.
- 2. Bidder must submit all the bid forms at Annexure IA duly filled and signed except the Bid Proformae at Appendix 10, 19, 20 etc. which should be used for preparation of documents as required. Foreign bidders not having fixed establishment/permanent address in India should submit Appendix 13. D.G. Shipping Guidelines are provided at Appendix 11 & 24 for reference.
- 3. Bidder should submit the current certificate of registry of vessel which has the name of existing owner of the offered vessel.

- 4. The consent letter for the vessel should be submitted as per BEC Clause B.1.8.0.
- 5. Ideally the digital signatory of the bid should also sign the physical documents wherever required, and Power of Attorney or authorization document to be submitted as per 7.10 and 9.1 (i) of 'Instructions to bidders' should be in favour of the digital signatory. B.2.8.0 (maximum limit of mobilization charges), calculation of amount of Performance Bank Guarantee / Security Deposit, GCC Cl. 19 (Liquidated Damages) and GCC Cl. 35 (Limitation of Liability) shall be arrived as under:

Annualized Contract Value = (Total contract value quoted for 1095 days) / (3 years)
